Please take the time to fully complete this application before sending it in because if it is incomplete your business will not be considered.

PRODUCE

Use locally/regionally grown ingredients whenever possible.

The following are abundantly available and may be used or sold when in season or frozen fresh (from current season crop only) and sourced locally – tomatoes, corn, blueberries, strawberries, apples and peaches.

ANIMAL PRODUCTS

Meat, poultry, eggs, wool, fleece

List type and breed of animal and finished products.

BEE PRODUCTS

Honey, Candles, Soap

List products.

SEAFOOD

Wild Caught Local fish and shellfish (non-local fish may not be sold)

List docks, waters fished

BEVERAGES

List types you plan to sell. Coffee (roasting location), Juices (source farm), Cider

PRESERVES

Jams, jellies

List products and source farm where fruit/produce is grown

BAKED GOODS/PREPARED FOODS

Baked from scratch, no mixes, use regional fruit.

Regional grown fruit must be used when available or frozen fresh (from current season crop only).

List ingredients, source farms (name and location) for the following ingredients if used (tomatoes, corn, blueberries, strawberries, apples and peaches)
