Farmers:

- \*Are allowed to sell what they grow, raise or produce.
- \*May resell locally/regionally grown produce (NJ, NY or Eastern PA) is permitted but must be labelled.
- \*May not purchase produce through Restaurant Depot or other large wholesale venues for resell.
- \*Must keep receipts listing farm and location for resold produce so they will be available for inspection.
- \*Produce must be fresh and high quality. Baked goods/prepared foods must be made from scratch using ingredients sourced from local/regional farms (fruit, dairy).
